

Prince of Songkla University Announcement Subject: Regulations and Prohibitions on Student Dormitories, B.E. 2563

For the appropriate and effective operation of the PSU student dormitories, by virtue of Section 39 of the Prince of Songkla University Act B.E. 2559 and in accordance with the Regulations of Prince of Songkla University on Student Dormitories, B.E. 2563, Section 24, the university has issued the following announcement:

Clause 1: Regulations

1.1 Students who have the right to stay and wish to stay at the dormitory must proceed according to the date and time specified by the university. Doing otherwise is considered a waiver of this right.

1.2 Students staying at the dormitory must report to the dormitory and sign a form to acknowledge the delivery of furniture and appliances before moving in.

1.3 If students staying at the dormitory want change their current room, the students must get permission in writing.

1.4 Students staying at the dormitory must present their dormitory card to the staff who is responsible for dormitory work, or identify themselves by other means in accordance with university-specified guidelines.

1.5 Students who stay in the dormitory must keep the room clean and maintain the property of the dormitory.

1.6 For entering and exiting the dormitory, students must use only the university-designated entry and exit points.

1.7 Students staying at the dormitory must attend the dormitory orientation session as stipulated by the university.

1.8 Students staying at the dormitory must acknowledge and strictly comply with all dormitory rules.

1.9 Student staying at the dormitory must attend compulsory dormitory meetings and dormitory activities.

1.10 Students staying at the dormitory must cooperate in the operations related to the dormitory, such as saving electricity, water etc.

1.11 Students staying at the dormitory that are allowed to use private vehicles must park in the area specified by the dormitory

1.12 Visitors must access only the areas permitted by the dormitory.

1.13 When the university announces the closure of dormitory or the student loses the right to stay at the dormitory under any circumstances, must return furniture and appliances of the room back to the dormitory.

1.14 During dormitory closure, dormitory students must complete the transfer of personal belongings from the dormitory within the time specified.

1.15 Students who want to stay at the dormitory during dormitory closure must obtain permission from the university, which will be considered on a case-by-case basis.

1.16 Students staying at the dormitory must observe proper dress code and behavior.

Clause 2: prohibitions

2.1 Do not falsify documents.

2.2 Do not give false information to the dormitory.

2.3 Do not transfer the right to stay at the dormitory to others.

2.4 Do not commit offenses relating to life, body and liberty or cause controversy inside the dormitory or in the dormitory area.

2.5 Do not cause disturbances inside the dormitory or in the dormitory area.

2.6 No gambling or any gambling related actions inside the dormitory or in the dormitory area. If it is necessary to have gambling equipment for school or sports purposes, permission must be obtained from the person who is responsible for that particular dormitory division.

2.7 Do not organize any activities inside a dormitory or dormitory area without permission.

2.8 Using or possession of any liquor, intoxicants or narcotics inside the dormitory or in the dormitory area is prohibited.

2.9 Smoking is prohibited inside the dormitory or in the dormitory area, except on designated premises.

2.10 Possession of unlawful objects inside the dormitory or in the dormitory area is prohibited.

2.11 Do not commit any offense related to property, such as burglary, embezzlement, defrauding property belonging to others or to the university etc.

2.12 Do not offend or insult the professors or staff of the university, or the staff of the dormitory at Prince of Songkla University, or the board of the dormitory student committee.

2.13 Do not possess keys or other opening devices for the unauthorized access to another person's room or storage.

2.14 Do not enter another person's room without permission.

2.15 Do not record, possess or publish any type of pornography.

2.16 Do not post any documents or posters inside the dormitory or in the dormitory area without permission.

2.17 Do not wash, clean, or dry clothes, utensils or other equipment outside the designated areas provided by the dormitory.

2.18 Do not bring any type of electrical appliance into the dormitory without permission.

2.19 Do not cook in the dormitory without permission.

2.20 Do not use motorcycles or cars in the dormitory area without permission.

2.21 Do not make loud noises or do anything that disturbs others.

2.22 Do not take for personal use any materials, furniture or appliances that the dormitory has designated for public use.

2.23 Do not remove materials, furniture, or appliances from the dormitory room.

2.24 Do not do anything that may cause damage to the dormitory or to the property of the dormitory.

2.25 Keeping pets and feeding animals inside the dormitory or in the dormitory area are prohibited.

2.26 Climbing buildings, fences, walls and gates inside the dormitory or in the dormitory area is prohibited.

2.27 Do not conduct business inside the dormitory or in the dormitory area without permission.

2.28 Do not use rude words or show offensive behavior inside a dormitory or in dormitory area.

2.29 Do not violate the orders of university staff on duty, nor the orders and announcements of the university.

2.30 Do not violate privacy rights.

2.31 Do not perform any sexual acts in the dormitory or in dormitory area.

2.32 Any form of voyeurism, including making photos and recordings of others in showers and toilets, is prohibited.

2.33 Do not bring others into the dormitory without permission.

Clause 3: the President is authorized to amend, interpret and predicate any acts not specified or clarified herein, and to change the provisions herein for special cases as deemed appropriate. The President's decision is considered final.
